



## **REBOUND SYNPAVE WARRANTY**

Rebound Synpave acrylic surfacing systems (the Product) are made from specified high quality raw materials and are manufactured to conform to each Product's Quality Standard under the Rebound Ace Sports Pty Ltd Total Quality Management Program.

Rebound Synpave Products when applied to a properly prepared surface to the manufacturer's written specifications by an Approved Registered Applicator (Advantage Sports & Leisure) shall provide a long wearing, weather and UV light stable court surface coating suitable for tennis, netball and related activities for a minimum period of five (5) years in domestic and commercial applications.

Under this Warranty, Advantage Sports & Leisure's sole liability is limited to the replacement of the applied Product and any repair work directly related to the replacement of the Product in areas defined and accepted as forming part of a claim properly lodged and accepted under the terms of this Warranty.

Limitations on Coverage of Warranty:

- This Warranty is exclusive of normal wear and tear.
- Product must be maintained in accordance with the Care and Maintenance Manual\*.

Additionally, this Warranty specifically excludes:

- Damage caused by faulty design and/or construction of the structure or sub-base or substrate.
- Damage caused by movement or failure of the base condition.
- Failure of the Product due to mechanical failure of the surface or components thereof to which the product was applied, including failures of expansion joints, flashings or metal work.
- Damage caused by concentrated loads.
- Damage caused by penetration of the surface by plant or animal life.
- Damage caused by exceptional weather conditions, hailstorms and acts of God.
- Damage caused by sub-surface penetration of water or other liquids, including inadequate drainage or pooling of water.
- Damage caused by abuse or negligence or wilful or accidental damage.
- Damage caused by excessive use including, but not limited to, areas evidencing mechanical abrasion of the top surface to an extent clearly in excess of surrounding undisturbed areas.
- Other factors which were or are outside of the control of Advantage Sports & Leisure.

This Warranty is in lieu of all other warranties and/or conditions whether expressed or implied and all other responsibilities on the part of Advantage Sports & Leisure. In no event should Advantage Sports & Leisure be liable or held accountable for any consequential, economic or other indirect loss or damage resulting from any such cause.

Receipt of full payment for the project is a condition precedent to the operation and effect of this Warranty. If full payment for the project is not received this warranty will be invalid.

Claims under this Warranty should be submitted to Advantage Sports & Leisure within seven (7) days of discovery of the defect and within the Warranty period. Advantage Sports & Leisure will provide any replacement or repair of Product covered under this Warranty within a reasonable time period from date of complaint.
